Senior/Disabled Reduced Rates Application

The City of Napavine offers reduced rates to qualified low-income seniors and disabled customers for water, sewer utilities provided by the City. The program includes both homeowners and renters who live in a residence receiving a separate City of Napavine water and/or sewer bill service.

Eligibility Requirements

- I am 62 years of age with total annual household income of \$40,000 or less for two or more. Or single with a total annual household income of \$30,000 or less.
- OR-**
- I am 18 years of age, or older, and retired from gainful employment by reason of disability with total annual household income of \$40,000 or less for two or more. Or single with a total annual household income of \$30,000 or less.
